

ORDINANCE NO. 2290

1 AN ORDINANCE relating to the County of King,
2 State of Washington; providing for the
3 redistricting and reapportionment thereof;
4 repealing Ordinance No. 725 and K.C.C.
5 1.20.010 through 1.20.110.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 SECTION 1. For the election of councilmembers of the King
8 County Council, the territory of King County of the State of
9 Washington shall be divided into nine districts, numbered one
10 through nine, as described in this ordinance. The boundaries
11 referred to in this ordinance shall correspond as nearly as
12 practical with the boundaries of election precincts, municipalities
13 and census tracts and shall be drawn to produce districts with
14 compact and contiguous territory, composed of economic and
15 geographic units and approximately equal in population. The
16 Council shall enact a districting and apportionment ordinance at
17 least every five years in compliance with Section 650 of the King
18 County Charter.

19 SECTION 2. Council District No. 1 shall consist of the
20 following census tracts or portions thereof: 1; 2; 3; 4; 5; 6; 7;
21 8; 9; 10, except block group 2; 11, except block group 2; 12, except
22 block group 2; 201; 202; 203; 204; 205; 206; 207; 208; 209; 210;
23 211; 212; 213; 214; 215; 216; 217; 218; 220, block group 9, except
24 blocks 8 and 9; 221, except block 902; and 223.

25 SECTION 3. Council District No. 2 shall consist of the
26 following census tracts or portions thereof: 10, block group 2;
27 11, block group 2; 12, block group 2; 18; 19; 20; 21; 22; 23; 24;
28 25; 26; 27; 28, block groups 1, 2 and 3, blocks 1, 2, 3, 4, 5 and 6;
29 36; 37; 38; 39; 40; 41; 42; 43; 44; 45; 46; 50; 51; 52; 53; 54;
30 61; 62; 63; and 78.

31 SECTION 4. Council District No. 3 shall consist of the
32 following census tracts or portions thereof: 219; 220, except block
33 group 9, blocks 1, 2, 3, 5, 7 and 10; 221, block 902; 222; 224; 225;
34 226; 227; 228; 229; 230; 231; 232; 234, blocks 408, 409, 410, 411,
35 412 and 413; 236, except block group 2 and blocks 107, 301, 302,

1 303, 304, 305, 306, 307, 308, 309, 310, 314, 315, 608, 609 and 611;
2 237; 238; 239, except block group 7; 240; 241; 242; 323; 324; 325;
3 327; 328; and 329.

4 SECTION 5. Council District No. 4 shall consist of the
5 following census tracts or portions thereof: 13; 14; 15; 16; 17;
6 28, block groups 4, 5 and 3, blocks 7, 8, 9, 10, 11 and 12; 29;
7 30; 31; 32; 33; 34; 35; 47; 48; 49; 55; 56; 57; 58; 59; 60; 67; 68;
8 69; 70; 71; 72; 73; 80; and 81.

9 SECTION 6. Council District No. 5 shall consist of the
10 following census tracts or portions thereof: 64; 65; 66; 74; 75;
11 76; 77; 79; 82; 83; 84; 85; 86; 87; 88; 89; 90; 91; 92; 93; 94; 95;
12 100; 101; 102; 103; 104; 109; 110; 111; 117; 118; and 119, block
13 groups 1, 2 and 6.

14 SECTION 7. Council District No. 6 shall consist of the
15 following census tracts or portions thereof: 233; 234, except blocks
16 408, 409, 410, 411, 412 and 413; 235; 236, block groups 2 and 3,
17 except blocks 11, 12 and 13, and except blocks 608, 609 and 611;
18 239, block group 7; 243; 244; 245; 246; 247; 248; 249; 250; 251;
19 252; 253; 254; 255; 256; 257; 258; 259; 262, except block group 5;
20 319, block groups 1, 2, 3, 5, and blocks 904, 908, 909, 910 and 911,
21 and enumeration district 307; 321; 322; and 326.

22 SECTION 8. Council District No. 7 shall consist of the
23 following census tracts or portions thereof: 120; 121; 267; 274;
24 275; 276; 277; 278; 279; 280; 284; 285; 286; 287; 288; 289; 290;
25 291; 298, blocks 104, 105, 106, 107, 108 and 202; 300; 301; 302;
26 and 303, except block group 1, blocks 2, 4, 5, 6, 7, 8, 10, 11, 12
27 and 14, and except blocks 914, 915, and 917.

28 SECTION 9. Council District No. 8 shall consist of the
29 following census tracts or portions thereof: 96; 97; 98; 99; 105;
30 106; 107; 108; 112; 113; 114; 115; 116; 119, block groups 3, 4 and
31 5; 260; 261; 262, block 5; 263; 264; 265; 266; 268; 269; 270; 271;
32 272; 273; 281; and 282.

1 SECTION 10. Council District No. 9 shall consist of the
2 following census tracts or portions thereof: 283; 292; 293; 294;
3 295; 296; 297; 298, except blocks 104, 105, 106, 107, 108, and 202;
4 299; 303, block group 1, blocks 2, 4, 5, 6, 7, 8, 10, 11, 12 and 14,
5 and blocks 914, 915, and 917; 304; 305; 306; 307; 308; 309; 310;
6 311; 312; 313; 314; 315; 316; 317; 318; 319, except block groups
7 1, 2, 3, 5, and except blocks 904, 908, 909, 910 and 911, and except
8 enumeration district 307; 320; 330; and 331.


9 SECTION 11. In the event any area of King County shall have
10 been omitted from the above description that area shall be
11 included in the County Council District closest to or encompassing
12 that area. If said area shall be bordered by two Council Districts,
13 it shall be included in the Council District with the least amount
14 of population.

15 SECTION 12. Ordinance 725 and K.C.C. 1.20.010, 1.20.020,
16 1.20.030, 1.20.040, 1.20.050, 1.20.060, 1.20.070, 1.20.080,
17 1.20.090, 1.20.100, and 1.20.110 are each repealed.
