AN ORDINANCE appropriating funds in the amount of \$68,200 from the unappropriated Current Expense Fund, fund balance, to Special Programs, Executive Contingency Fund, for settlement of litigation in the matters of Bryant Corporation v. King County and Weyerhaeuser Company v. King County, and amending Ordinance No. 2230, Section 49, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An additional appropriation in the amount of \$68,200 is hereby appropriated from the Current Expense Fund, fund balance to Special Programs, Executive Contingency Fund.

SECTION 2. The \$68,200 is appropriated in order to provide the Clerk of the King County Superior Court the money necessary for disbursement to the Weyerhaeuser Company in the amount of \$55,000 and to the Bryant Corporation in the amount of \$13,200 in settlement of the claims of said corporations against King County, Weyerhaeuser v. King County, cause no. 762451, and Bryant Corporation v. King County, cause no. 765492.

SECTION 3. Ordinance No. 2230, Section 49, as amended is hereby amended to read as follows:

From the Current Expense Fund there is hereby appropriated to:

PROVIDED THAT:

- 1) The Executive Contingency of ((~~\$155,787~~)) \$223,987 shall not be expended unless the County Executive certifies in writing that funds are available and requests that the County Council adopt an additional appropriation ordinance; Upon adoption of the ordinance and signing by the Executive, funds may be expended for the purpose specified;
