

ORDINANCE NO. 2343

AN ORDINANCE revising the Department of Public Works & Transportation Program, 1975 Streets and Roads Construction Sub-Program, Capital Improvement Program, amending Ordinance No. 2230, Section 69 - Capital Project Funds, County Road, to increase funding for cost increases to complete construction contract for project known as Northeast 203rd Street (204071).

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An appropriation of \$50,000 to the Department of Public Works & Transportation Program, 1975 Streets and Roads Construction Subprogram, Capital Improvement Program, County Road Fund is hereby approved and adopted for the project "Northeast 203rd Street (204071)" from anticipated County Road fund balance revenues. Funds will be used for increased costs of labor and materials of a complete construction contract.

SECTION 2. Ordinance No. 2230, Section 69 - Capital Project Funds, as amended, is hereby amended to read:
