ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Gigio's Restaurant, Division of Land Use Management File No. 136-74-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Gigio's Restaurant petitioned on May 15, 1974, that the property described in Section 3 below to be reclassified from SR (Potential RM 1800) to CG and this application was assigned Division of Land Use Management File No. 136-74-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on July 2, 1974, and hearing was held by the Examiner on the matter July 9, 1974. The report of the Examiner was filed with the Clerk of the King County Council on November 12, 1974, and the Council approved the reclassification by Motion No. 1827 on December 9, 1974, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.


SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by

reclassifying that property described and shown in Section 3,  
appendices A and B above, to RM 900 and directs that Area Map  
E-16-24-5 be modified to so designate.



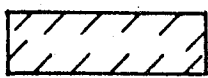
