ORDINANCE NO. 2410

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Church of the Nazarene, Washington Pacific District, Division of Land Use Management File No. 434-73-P

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Church of the Nazarene, Washington Pacific District, petitioned on October 5, 1973, that the property described in Section 3 below be reclassified from RS-7200 to RM-900 and this application was assigned Division of Land Use Management File No. 434-73-P.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on November 20, 1973 and hearing was held by the Examiner on the matter November 27, 1973. The report of the Examiner was filed with the Clerk of the King County Council on December 12, 1973 and the Council approved the reclassification by Motion No. 1394 on January 21, 1974 subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 900 and
