

ORDINANCE NO. 2413

AN ORDINANCE relating to setting a date of election for annexation of territory to Lakehaven Sewer District known as Country Lanes.

PREAMBLE:

The requirements of RCW 56.24.070 and RCW 36.93.090, 36.93.093 and 36.93.100 for annexation of territory to a sewer district have been fulfilled by Lakehaven Sewer District.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The proposed annexation of territory known as Country Lanes to Lakehaven Sewer District will be conducive to the public health, welfare and convenience and will be of special benefit to the land included within the boundaries of the territory proposed to be annexed.

SECTION 2. A special election shall be held on the 5<sup>th</sup> day of August, 1975, within the territory of the proposed annexation as hereinafter described, between the hours of 8:00 o'clock A.M. and 8:00 o'clock P.M., for the purpose of submitting to the qualified electors within the territory proposed to be annexed the proposition of annexing said territory to Lakehaven Sewer District.

SECTION 3. The boundaries of the territory to be annexed to Lakehaven Sewer District are hereby described as follows:

Beginning at the intersection of the northerly margin of Maltby Road (S.S.H. No. I-V) and the Easterly line of Section 6, Township 21 North, Range 4 East, W.M.; Thence Westerly along said Northerly margin to its intersection with the Northerly extension of the Westerly line of the plat of Roy H. Emmett's Country Lane according to plat thereof recorded in Volume 62, page 20, records of King County, Washington; Thence Southerly along said Northerly extension across Maltby Road and the said Westerly line of Emmett's Country Lane to the Southwest corner thereof which is also a point on the Southerly line of said Section 6; Thence Westerly along said Southerly line of Section 6, also being the northerly line of Section 7, Township 21 North, Range 4 East, W.M. to its intersection with the centerline of said Maltby Road; Thence Southwesterly along said centerline to its intersection with the Southeasterly prolongation of the Southwesterly line of Lot 17, Block 8, Plat of Marine View Estates Addition, as recorded in Volume 44 of Plats, pages 59 and 60, records of King County,

 2 Thence Southeasterly along said Southeasterly  
 3 prolongation to its intersection with the South line of  
 4 the North quarter of said Section 7;  
 5 Thence Easterly along said South line to the East line  
 6 of said Section 7;  
 7 Thence Northerly along said East line of Section 7,  
 8 also being the West line of Section 8, Township 21 North,  
 9 Range 4 East, W.M. and along the East line of Section  
 10 6, Township 21 North, Range 4 East, W.M. to the Point  
 11 of Beginning.

12 TOGETHER WITH

13 Beginning at the Northeast corner of the Northwest  
 14 quarter of the Northwest quarter of Section 8, Township  
 15 21 North, Range 4 East, W.M.;

16 Thence Westerly along the North line of said Section 8  
 17 also being the South line of Section 5, Township 21  
 18 North, Range 4 East, W.M. to the Northeast corner of  
 19 Lot 7, Plat of Holiday Park No. 2 as recorded in Volume  
 20 68, page 75, records of King County, Washington;

21 Thence Southerly along the East line and Southerly  
 22 extension thereof to the centerline of South 304th  
 23 Place;

24 Thence Westerly along the centerline of South 304th  
 25 Place to the intersection with the Northerly extension  
 26 of the East line of Lot 8 of said plat of Holiday Park  
 27 No. 2;

28 Thence Southerly along the East line of said Lot 8 and  
 29 the Northerly extension thereof to the Southeast corner  
 30 of said Lot 8;

31 Thence Westerly along the South line of said Lot 8 to  
 32 the Northeast corner of Lot 10 of said plat;

33 Thence Southerly along the East line of said plat of  
 Holiday Park No. 2 and continuing Southerly along the  
 East line of the plat of Holiday Park No. 3 as recorded  
 in Volume 72, page 35, records of King County,  
 Washington, to the Southeast corner of Lot 28 of said  
 plat of Holiday Park No. 3;

Thence Southwesterly across South 308th to the  
 Northeast corner of Lot 29 of said plat of Holiday Park  
 No. 3;

Thence Southerly to the Southeast corner of Lot 30 of  
 said plat of Holiday Park No. 3 which is also the  
 Southwest corner of the plat of Emberwood No. 3 as  
 recorded in Volume 73, page 8, records of King County,  
 Washington;

Thence Easterly along the South line of said plat of  
 Emberwood No. 3 to the Southeast corner of Lot 22 of  
 said plat;

Thence Northerly along the Easterly line of said Lot 22  
 and the Easterly line of Lot 23 of said plat and the  
 Northerly prolongation thereof to its intersection with  
 the South line of the Northwest quarter of the  
 Northwest quarter of said Section 8;

Thence Easterly along said South line to the East line  
 of said subdivision;

Thence Northerly along said East line to the Point of  
 Beginning.

1            SECTION 4. In submitting said proposition to the voters for  
2 their approval or rejection, the proposition shall be expressed  
3 on the ballot in the following terms:


- 4            For Annexation to Lakehaven Sewer District

6            SECTION 5. Notice of election shall be published as  
7 required by law.
