

ORDINANCE NO. 2525

2 AN ORDINANCE appropriating \$192,125 to the Grant
3 Fund from the Municipality of Metropolitan
4 Seattle for King County participation in a water
5 quality planning program in the Green and Cedar
6 River Basins and allocating these funds among
7 several County agencies in accordance with a
8 mutually agreed upon work program.

9 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

10 SECTION 1. An appropriation of \$192,125 is hereby approved
11 and adopted to the Grant Fund from the Municipality of Metro-
12 politan Seattle to support the participation of King County in
13 a water quality planning program being conducted in the Green
14 and Cedar River Basins under provisions of the Federal Water
15 Quality Control Act Amendments of 1972 (P.L. 92-500).

16 PROVIDED:

- 17 1. For purposes of this grant the Department of Planning and
18 Community Development shall be the lead county department
19 and responsible for the completion of all responsibilities
20 assigned under this grant to the county, shall coordinate
21 all work program activity and review and approve in advance
22 all disbursement of associated grant funds, and
23 2. The administrative and lead agency responsibilities
24 assigned to the Department of Public Works by Motion 1845
25 for the Surface Water Task Force, shall be transferred to
26 the Department of Planning and Community Development,
27 effective January 1, 1976.

28 SECTION 2. Agencies shall use funds allocated to them for the
29 completion of the following program elements:
