

ORDINANCE NO. 2568

AN ORDINANCE relating to the annexation of an area known as Cedar Downs to Cascade Sewer District.

WHEREAS, Cascade Sewer District has found the petition for annexation of an area known as Cedar Downs to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for sewer facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as Cedar Downs and described in Section 2 herein is approved.

SECTION 2. The area known as Cedar Downs to be annexed is described as follows:

Beginning at the South quarter corner of Section 20, Township 22 North, Range 6 East, W.M. in King County Washington which is also a point on the existing sewer district boundary;

Thence North along the North-South centerline of said Section 20 to its intersection with the North line of the South half of the South half of said Section 20;

Thence East along said North line to its intersection with the East line of said Section 20 (also being the West line of Section 21, Township 22 North, Range 6 East, W.M.);

Thence continuing East along the North line of the South half of the South half of said Section 21 to its intersection with the centerline of the Witte Road Southeast;

Thence Southerly along said centerline to its intersection with the South line of said Section 21 (also being the North line of Section 28, Township 22 North, Range 6 East, W.M.);

Thence West along said North line to its intersection with the East line of the West half of the West half of said Section 28;

Thence South along said East line to its intersection with the Northerly margin of Silvan Road (215th Place Southeast and Southeast 258th Street) as platted in the Plat of Pipe Lake and Lake Lucerne as recorded in Volume 28 of Plats, Page 49, Records of King County, Washington;

Thence Westerly (Southeast 258th Street), Southwesterly (215th Place Southeast) and Westerly (Southeast 261st Street) along said margin of Silvan Road to its intersection with the West line of said Section 28 (also being the East line of Section 29, Township 22 North, Range 6 East, W.M.);

Thence Northerly along the East line of said Section 29 to its intersection with the South line of the North half of the North half of said Section 29;


Thence East along said South line to its intersection with the North-South centerline of said Section 29;

Thence North along said North-South centerline to the North quarter corner of said Section 29 (also being the South quarter corner of Section 20, Township 22 North, Range 6 East, W.M.) and the point of beginning.

PASSED this 15th day of December, 1975.


