7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. Ordinance No. 2517, Section 2, as amended, is
9 hereby amended to read as follows:

10 The Council of King County, Washington, finds that the
11 amounts of the levies necessary to raise the amounts of the
12 estimated expenditures as so finally determined for the year
13 1976, less the total of estimated revenues from sources other
14 than taxation, including available surplus, and such expenditures
15 as are to be met from bond warrant issues, be and the same
16 are hereby fixed as follows:




