

ORDINANCE NO. 2581

1 AN ORDINANCE relating to the reorganization and  
2 consolidation of King County departments; amend-  
3 ing Ordinance 1438, Section 3, Subsection (b)  
4 and K.C.C. 2.16.050, & Ordinance 2493, Section 5.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 1438, Section 3, Subsection (b)  
7 and KCC 2.16.050 are hereby amended to read as follows:

8 (b) DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT. The  
9 Department of Planning and Community Development shall be  
10 responsible for the administration of the Division of Parks,  
11 Planning (~~and Land-Use-Management~~), Architecture, Building  
12 and Land Development, and Youth Affairs (~~and Housing and~~  
13 ~~Community-Development~~)).

14 (1) PARKS & RECREATION DIVISION. The Parks and Rec-  
15 reation Division shall be responsible for the administration of  
16 the county park and recreation system, including acquisition,  
17 development and maintenance of areas and facilities, planning  
18 and operation of county recreation programs, and the administra-  
19 tion of the King County Fair.

20 (2) PLANNING (~~AND-LAND-USE-MANAGEMENT~~) DIVISION.  
21 The Planning (~~and Land-Use-Management~~) Division shall be  
22 responsible for the (~~planning and administration of the county~~  
23 ~~land-use-management-program~~) preparation of all plans for the  
24 development of the county (~~and implementation of these ordinances~~  
25 necessary to carry out the above plans) including the  
26 administration of the county's responsibilities under the Housing  
27 and Community Development Act of 1974. In carrying out the above  
28 responsibilities, the Division shall advise all agencies of the  
29 county on planning, shall coordinate planning of the county with  
30 other governmental agencies and assist the Budget Division in  
31 developing capital improvement programs.

1           (3) BUILDING AND LAND DEVELOPMENT DIVISION. The  
2 Building and Land Development Division shall be responsible for  
3 the administration of the county building, ((and)) housing,  
4 zoning and subdivision codes, including issuance of permits and  
5 enforcement, and shall administer other codes and regulations  
6 assigned to it.

7           (4) ARCHITECTURE DIVISION. The Architecture Division  
8 shall be responsible for the administration of the King County  
9 Design Commission, shall administer all projects within the  
10 purview of the Design Commission, and shall administer all other  
11 projects assigned to it.

12           (5) YOUTH AFFAIRS DIVISION. The Youth Affairs Divi-  
13 sion shall be responsible for the administration of the County  
14 youth programs, including administration of programs funded by  
15 federal and state agencies.

16           ~~((6)--HOUSING-AND-COMMUNITY-DEVELOPMENT-DIVISION. The~~  
17 ~~Housing-and-Community-Development-Division-shall-be-responsible~~  
18 ~~for-the-planning-and-development-of-the-County's-programs-in~~

22           SECTION 2. Ordinance 2493, Section 5 is hereby amended to  
23 read as follows:

24           This ordinance shall take effect on January 1, 1976 ((  
25 ~~except-that-Section-2, Subsection-(b)-(6), in-order-to-provide-for~~

1 an-orderly-transfer-of-functions, shall take effect on or before  
2 April 17, 1976, as is designated by the County Executive by  
3 Executive Order)).
