9 ORDINANCE NO. 2656

10 AN ORDINANCE amending King County Zoning Resolution No.
11 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of Philip
M. Viehe, Building and Land Development Division, File No.
253-75-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Philip M. Viehe petitioned on August 13, 1975, that the
15 property described in Section 3 below be reclassified from RD-3600 to
16 RM-2400 and this application was assigned Building and Land Development
17 Division File No. 253-75-R.

18 SECTION 2. The report and recommendation of the Building and Land
19 Development Division was transmitted to the Zoning and Subdivision Examiner
20 on October 21, 1975, and hearing was held by the Examiner on the matter
21 October 28, 1975. The report of the Examiner was filed with the Clerk of the
22 King County Council on November 20, 1975, and the Council approved the
23 reclassification by Motion No. 2239 on December 8, 1975.

24 SECTION 3. The legal description of the property to be reclassified is
25 attached as Appendix A and is hereby made a part of this ordinance. The
26 above described property is shown on the attached map which is designated
27 Appendix B and is hereby made a part of this ordinance.

28 SECTION 4. The King County Council does hereby amend King County
29 Zoning Code, Resolution No. 25789, as amended, by reclassifying that property
30 described and shown in Section 3, Appendices A and B above, to RM-2400 and

1 directs that Area Map W 19-23-4 be modified to so designate.


