ORDINANCE NO. 2669

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kenneth E. Johnson, Division of Land Use Management File No. 107-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Kenneth E. Johnson, petitioned on January 20, 1975, that the property described in Section 3 below be reclassified from SR (Potential RM-900) to RM-1800 and this application was assigned Division of Land Use Management File No. 107-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on April 22, 1975, and hearing was held by the Examiner on the matter April 29, 1975. The report of the Examiner was filed with the Clerk of the King County Council on June 6, 1975, and the Council approved the reclassification by Motion No. 2039 on June 16, 1975, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM-2400 and


