ORDINANCE NO.

AN ORDINANCE relating to the annexation of an area known as Lattimer to King County Water District No. 124.

WHEREAS, King County Water District No. 124 has found the petition for annexation of an area known as Lattimer to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 124 of the area known as Lattimer and described in Section 2 herein is approved.

SECTION 2. The area known as Lattimer to be annexed is described as follows:

Portions of Marine Hills No. 17, portions of Marine Hills West, and portions of Tax Lot 13,  $SW_4$   $SE_4$  Section 32, Township 22 N., R. 4 E., W.M., together with all of Marine Hills East more particularly described as follows:
