

ORDINANCE NO. 2740

AN ORDINANCE relating to the annexation of an area known as Thiele to King County Water District No. 82.

WHEREAS, King County Water District No. 82 has found the petition for annexation of an area known as Thiele to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 82 of the area known as Thiele and described in Section 2 herein is approved.

SECTION 2. The area known as Thiele to be annexed is described as follows:

 10 centerline of E Lake Sammamish Parkway SE and the
 11 True Point of Beginning; thence N 52-47-40 W a distance
 12 of 130 feet; thence N 83-28-10 W to the Easterly shore
 13 line of Lake Sammamish; thence Northerly along said
 14 shore line to the South line of the North 7 feet of
 15 Govt. Lot 2, said line being also known as the North
 16 line of Lot 31, Connell's Sub-Division Govt. Lot
 17 2, unrecorded; thence Easterly along said line and
 18 its easterly projection to the centerline of the E.
 19 Lake Sammamish Parkway NE; thence Southerly along said
 20 centerline to the True Point of Beginning.
