9 ORDINANCE NO. 2766

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
Norman A. Searle, Building and Land Development Division
File No. 108-76-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Norman A. Searle petitioned on January 13, 1976, that the
15 property described in Section 3 below be reclassified from SR to RM-900 and
16 this application was assigned Building and Land Development Division File
17 No. 108-76-R.

18 SECTION 2. The report and recommendation of the Building and Land
19 Development Division was transmitted to the Zoning and Subdivision Examiner
20 on March 2, 1976, and hearing was held by the Examiner on the matter March
21 9, 1976. The report of the Examiner was filed with the Clerk of the King County
22 Council on March 31, 1976, and the Council approved the reclassification by
23 Motion No. 2401 on April 5, 1976.

24 SECTION 3. The legal description of the property to be reclassified is
25 attached as Appendix A and is hereby made a part of this ordinance. The
26 above described property is shown on the attached map which is designated
27 Appendix B and is hereby made a part of this ordinance.

28 SECTION 4. The King County Council does hereby amend King County
29 Zoning Code, Resolution No. 25789, as amended, by reclassifying that property
30 described and shown in Section 3, Appendices A and B above, to RM-2400
