

ORDINANCE NO. 2800

1 AN ORDINANCE appropriating \$7,500 from additional  
2 revenues received from Pierce and Snohomish Counties  
3 pursuant to interlocal agreement, to Special Programs  
4 for Consulting and other related services for the  
establishment of a regional planning organization  
in the Central Puget Sound Region, amending  
Ordinance No. 2544, Section 43, as amended.

5 PREAMBLE:

6 King County has entered into an interlocal agreement with the Counties  
7 of Pierce and Snohomish for the purpose of retaining consulting and related  
8 services. Said interlocal agreement provides for King County to administer  
9 all contracts for such services and for the Counties of Pierce and  
10 Snohomish to reimburse King County an equal share of all costs incurred.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. An appropriation in the amount of \$7,500 from revenues  
13 received from Pierce and Snohomish Counties pursuant to the attached  
14 interlocal agreement to Special Programs for Consulting and other related  
15 services for the establishment of a regional planning organization in the  
16 Central Puget Sound Region is hereby approved and adopted.

17 SECTION 2. Ordinance No. 2544, Section 43, as amended, is hereby  
18 amended to read as follows:



2/4/76


A contract of employment, dated February 4, 1976, between King County and Edward Heavey is hereby amended as follows:
