9 ORDINANCE NO. 2856

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
Gwladys M. McHarg, Building and Land Development Division
File No. 233-76-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Gwladys M. McHarg petitioned on March 31, 1976, that the
16 property described in Section 3 below be reclassified from SR to RM-1800 and
17 this application was assigned Building and Land Development Division File No.
18 233-76-R.

19 SECTION 2. The report and recommendation of the Building and Land
20 Development Division was transmitted to the Zoning and Subdivision Examiner
21 on May 18, 1976, and hearing was held by the Examiner on the matter May 25,
22 1976. The report of the Examiner was filed with the Clerk of the King County
23 Council on June 23, 1976, and the Council approved the reclassification by
24 Motion No. 2557 on June 28, 1976, subject to conditions which will be satisfied
25 per the "P" suffix.

26 SECTION 3. The legal description of the property to be reclassified is
27 attached as Appendix A and is hereby made a part of this ordinance. The above
28 described property is shown on the attached map which is designated Appendix
29 B and is hereby made a part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King County
31 Zoning Code, Resolution No. 25789, as amended, by reclassifying that property

1 described and shown in Section 3, Appendices A and B above, to RM-1800-P and
2 directs that Area Map W 16-21-4 be modified to so designate. 2856

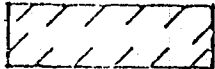
