AN ORDINANCE relating to the annexation of an area known as Highline to King County Water District No. 75.

WHEREAS, King County Water District No. 75 has found the petition for annexation of an area known as Highline to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 75 of the area known as Highline and described in Section 2 herein is approved.

SECTION 2. The area known as Highline to be annexed is described as follows:

The S^{1}_{2} of the SE^{1}_{4} of Section 17, Township 22 North, Range 4 East, W.M., King County, Washington.

LESS that portion lying west of the centerline of Marine View Drive.

LESS the north 497.75 feet of the W½ of the SW¼ of the SE¼ of said Section 17.

Together with the following:

Starting at the NE corner of Section 20, Township 22 North, Range 4 East, W.M.; thence southerly along east line of said Section to the centerline of South 242nd Street;

Thence westerly along said centerline to the southerly extension of the east boundary of the Plat of College Place (70-62);

Thence northerly along said southerly extension and said east boundary to the NE corner of sai d Plat;

Thence westerly along north boundary of said Plat to the intersection with the centerline of block 2 of the Des Moines Water Front Add (4-96);
