

ORDINANCE NO. 2860

1 AN ORDINANCE relating to the annexation of an
2 area known as 360th Street to Lakehaven Sewer
3 District.

4 WHEREAS, Lakehaven Sewer District has found the petition for
5 annexation of an area known as 360th Street to be sufficient and
6 has, by resolution, concurred with the proposed annexation; and

7 WHEREAS, state law requires approval of the proposed
8 annexation by the King County Council and the King County
9 Boundary Review Board; and

10 WHEREAS, the King County Council finds said annexation is in
11 the public interest and is not inconsistent with the county
12 comprehensive plan,

13 THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. The annexation by Lakehaven Sewer District of
15 the area known as 360th Street and described in Section 2 herein
16 is approved.

17 SECTION 2. The area known as 360th Street to be annexed is
18 described as follows:

19 Beginning at the intersection of the North-South
20 centerline and the North line of the South half of the
21 Northwest quarter of Section 28; Township 21 North;
Range 4 East, W.M. in King County, Washington;

22 Thence Southerly along said North-South centerline to
23 the North line of the South half of the Southwest
quarter of the Southeast quarter of said Section 28;

24 Thence Easterly along said North line to the East line
25 of the Southwest quarter of the Southeast quarter of
said Section 28:

26 Thence Southerly along said East line to the South line
27 of said Section 28 also being the North line of Section
33, Township 21 North, Range 4 East W.M.;

28 Thence continuing Southerly along the East line of the
29 West half of the East half of said Section 33 to the
centerline of Secondary State Highway Number 5-D;

30 Thence Northwesterly along said centerline to the North
31 line of said Section 33, also being the South line of
Section 28, Township 21 North, Range 4 East W.M.;

32 Thence continuing Northwesterly along said centerline
33 of Secondary State Highway Number 5-D to the West line
of the East half of the West half of said Section 28;

Thence Northerly along said West line to the North line of the South half of the Northwest quarter of said Section 28;

Thence Easterly along said North line to the point of beginning.
