AN ORDINANCE establishing Television Reception Improvement District No. 2, King County, Washington, in Mirrormont Precinct; establishing a board of five members.

PREAMBLE: The formation of a television improvement district in part of the Tiger Mountain area shall be to serve the public interest, convenience and necessity in the construction, maintenance and operation of television translator stations, including appropriate electric or electronic devices for increasing television program distribution, but said purposes are not meant to include the construction or operation of television cable systems commonly known and referred to as cable TV systems or CATV. The requirements of R.C.W. 36.95.030 have been met.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby established a district designated Television Reception Improvement District No. 2, King County, Washington. The boundaries of the proposed district shall be:

Mirrormont (Vol. 71, pp. 22-26); Mirrormont Division No. 2 (Vol. 75, pp. 38-40); Mirrormont Division No. 3 (Vol. 77, pp. 46-49); Mirrormont Division No. 4 (Vol. 80, pp. 21-26); Mirrormont Division No. 5 (Vol. 88, pp. 17-23); ALSO the NW¼ of the SE¼ of the NW¼ of Section 25, Township 23 N., Range 6E., W.M.

SECTION 2. There is hereby established a Board of Television Reception Improvement District No. 2, King County, Washington, to be composed of five members appointed by the King County Council. Each member shall reside within the boundaries of the district. Each member shall serve a three-year term except on the first board one of the members shall be appointed for a one-year term and two to two-year terms.

SECTION 3. The Board of Television Reception Improvement District No. 2 shall comply with all regulations for operation
