ORDINANCE NO. 2919

AN ORDINANCE authorizing condemnation of property for the Jones Road Storm Drain System (Lake McDonald Drainage)

STATEMENT OF FACTS

- 1. The King County Council on August 2, 1976, by Ordinance No. 2818, did amend the 1976 Annual Budget for King County, and did provide therein for certain drainage projects and studies.
- 2. The Capital Budget and Program provides for the acquisition and construction of Jones Road Storm Drain System (Lake McDonald Drainage).
- 3. In order to acquire the property and property rights required to construct the Jones Road Storm Drain System (Lake McDonald Drainage), it is necessary for King County to condemn certain lands and property rights and rights in property for drainage purposes as hereinafter more particularly set forth.
- 4. The King County Council finds that the public health, safety, necessity and convenience demand that Jones Road Storm Drain System (Lake McDonald Drainage) be constructed within King County in accordance with the Capital Budget and Program, and that certain properties, property rights and rights in property be condemned, appropriated, taken and damaged for the construction of said drain system, as provided in this ordinance.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Council has deemed it necessary and in the best interest of the citizens of King County that the lands hereinafter described, and other property rights and/or rights in property be condemned, appropriated, taken and damaged for the purpose of constructing Jones Road Storm Drain System (Lake McDonald Drainage), subject to the making or paying of just compensation to the owners thereof in the manner provided by law.

Contains 27,028 Sq. Ft. or 0.62 Acres more or less. 8 SECTION 2. The King County Council determines that condemnation pro-9 ceedings are hereby authorized to acquire property and property rights and/ 10 or rights in property, together with the right to construct the Jones Road 11 Storm Drain System (Lake McDonald Drainage), together with the right to 12 construct and maintain slopes for cuts and fills on certain abutting property 13 described herein, for the purposes of the subject storm drain system. 14 SECTION 3. The attorneys for King County are hereby authorized and 15 directed to begin and prosecute the proceedings provided by law to condemn, 16 take and appropriate the land and other property and property rights necessary 17 to carry out the provisions of this ordinance.
