8 ORDINANCE NO. 2940

9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map thereof  
11 reclassifying certain property thereon at the request of  
12 L. B. Lumsden, ET UX, Building and Land Development  
13 Division File No. 139-76-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. L.B. Lumsden, ET UX petitioned on May 5, 1976, that the  
16 property described in Section 3 below be reclassified from RS 7200 (Potential  
17 RM-2400) to RM-1800 and this application was assigned Building and Land  
18 Development Division File No. 139-76-R.

19 SECTION 2. The report and recommendation of the Building and Land  
20 Development Division was transmitted to the Zoning and Subdivision Examiner  
21 on July 6, 1976, and hearing was held by the Examiner on the matter July 13,  
22 1976. The report of the Examiner was filed with the Clerk of the King County  
23 Council on August 4, 1976, and the Council approved the reclassification by  
24 Motion No. 2625 on August 9, 1976, subject to conditions which will be satisfied  
25 per the "P" suffix.

26 SECTION 3. The legal description of the property to be reclassified is  
27 attached as Appendix A and is hereby made a part of this ordinance. The above  
28 described property is shown on the attached map which is designated Appendix  
29 B and is hereby made a part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King County  
31 Zoning Code, Resolution No. 25789, as amended, by reclassifying that property  
described and shown in Section 3, Appendices A and B above, to RM-1800-P

1 and directs that Area Map E 16-26-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted  
3 in Motion No. 2625 and said conditions are incorporated herein as though fully  
4 set forth herein.

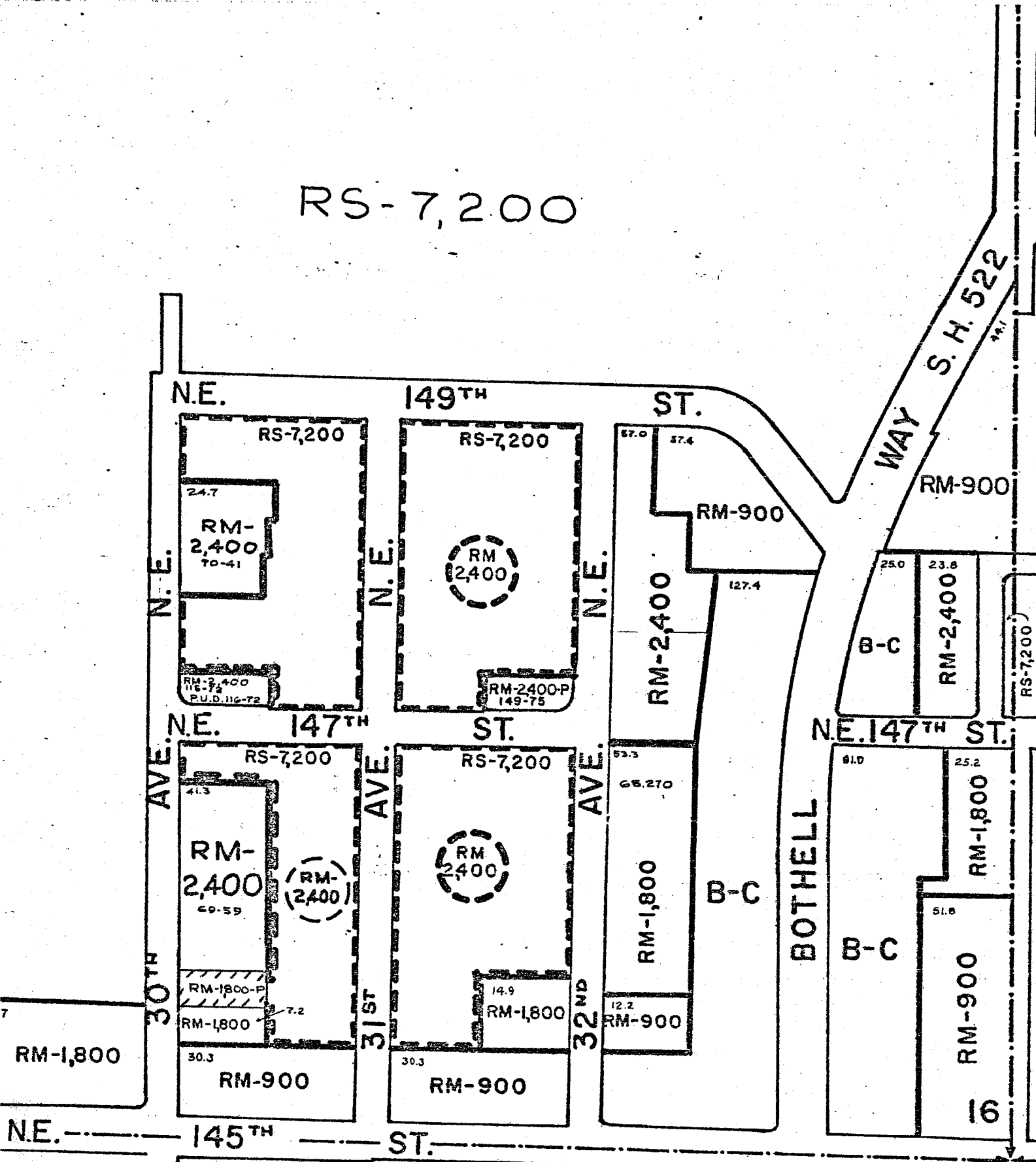
