ORDINANCE NO. 3003 76 - 1029

1 AN ORDINANCE relating to the Policy
2 Development Commission; amending Ordinance
2208, Section 8.

3 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

4 SECTION 1. Ordinance 2208, Section 8, is hereby amended as
5 follows:

6 Members of the Commission termed citizens-at-large shall
7 be appointed by the County Executive from nominees of County
8 Councilmembers and confirmed by a majority of the County Council.
9 Citizen-at-large members shall serve for two year terms or until
10 their successor is named and confirmed, with initial appointments
11 following the expiration of the terms of the nine citizen-at-large
12 members in December, 1976, of five citizen-at-large members being
13 for two years and four being for one year. ((and-shall-be-eligible
14 for-reappointment.)) Citizen-at-large members shall be eligible
15 for reappointment following a critical review by the Council and
16 Executive.

17 The Chairperson and Vice Chairperson of the Commission
18 shall be appointed by the County Executive and subject to Council
19 confirmation. The Chairperson and Vice Chairperson of the
20 Commission shall serve for two year terms or until their successor
21 is named and confirmed, with initial appointment following the
22 expiration of the terms of the Chairperson and Vice Chairperson
23 in December, 1976, of the Chairperson being for two years and
24 the Vice Chairperson being for one year. The Chairperson and
25 Vice Chairperson of the Commission shall be eligible for reappoint-
26 ment following a critical review by the Executive and Council.

27 Committee Chairpersons shall be appointed by the County Executive
28 and subject to Council confirmation, except that should the
29 Council choose to nominate a committee chairperson the Council
30 may do so, providing that the Executive may make an appointment
31 for the next citizen-at-large vacancy on the Commission,
32 effective upon confirmation of the County Council. Committee
33 Chairpersons shall serve for two year terms or until their

1 successor is named and confirmed, with initial appointments
 2 following the expiration of the terms of the seven Committee
 3 Chairpersons in December, 1976, of three Committee Chairpersons
 4 being for two years and four Committee Chairpersons being for
 5 one year. ((and-shall-be-eligible-for-reappointment---A
 6 critical-review-shall-take-plae-before-the-completion-of-each
 7 two-year-term;-prior-to-reappointment-)) Committee Chairpersons
 8 shall be eligible for reappointment following a critical review
 9 by the Executive and Council.
