9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map there of  
11 reclassifying certain property thereon at the request of  
Ray Van Hollebeke, Building and Land Development Division  
File No. 161-76-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Ray Van Hollenbeke petitioned on July 15, 1976, that the  
15 property described in Section 3 below be reclassified from RS-7200 to RM-1800  
16 and this application was assigned Building and Land Development Division  
17 File No. 161-76-R.

18 SECTION 2. The report and recommendation of the Building and Land  
19 Development Division was transmitted to the Zoning and Subdivision Examiner  
20 on September 7, 1976, and hearing was held by the Examiner on the matter  
21 September 14, 1976. The report of the Examiner was filed with the Clerk of the  
22 King County Council on October 14, 1976, and the Council approved the reclassi-  
23 fication by Motion No. 2819 on December 27, 1976, subject to conditions which  
24 will be satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be reclassified is  
26 attached as Appendix A and is hereby made a part of this ordinance. The above  
27 described property is shown on the attached map which is designated Appendix B  
28 and is hereby made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning  
30 Code, Resolution No. 25789, as amended, by reclassifying that property described  
31 and shown in Section 3, Appendices A and B above, to RD-3600-P and directs

1 that Area Map E 17-26-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted  
3 in Motion No. 2819 and said conditions are incorporated herein as though fully  
4 set forth herein.
