ORDINANCE NO. 3208

AN ORDINANCE making an appropriation in the maximum amount of \$260,000 to the Architecture Fund from the City of Seattle for the NWCR Building 267 Renovation Capital Improvement Project No. 004205; revising the 1977 Capital Improvement Budget and Program and amending Ordinance No. 2988, Section 70, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Contingent upon the execution of an Intergovernmental Agreement between the City of Seattle and King County, Washington; there is hereby approved and adopted an appropriation in the maximum amount of \$260,000 to the Architecture Fund from the City of Seattle for the NWCR Building 267 Renovation Capital Improvement Project No. 004205.

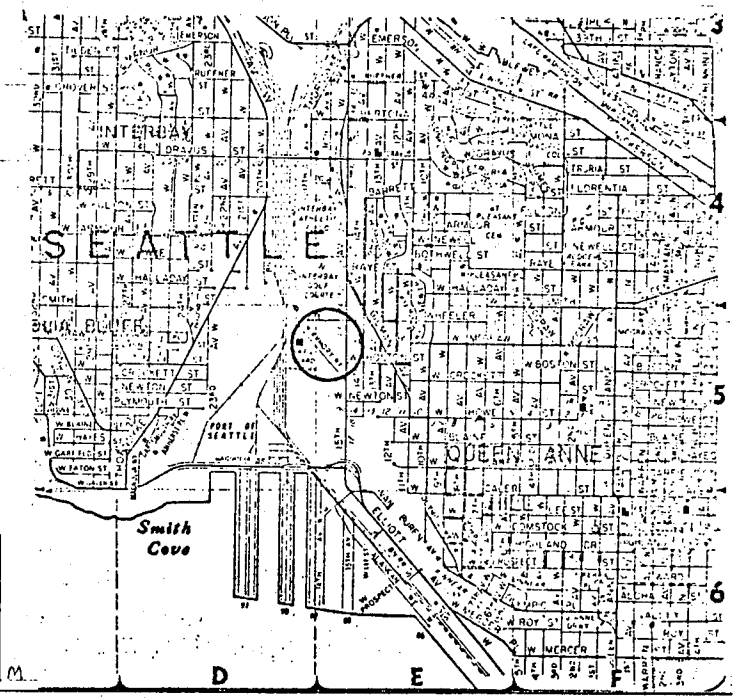
