8 ORDINANCE NO. 3267

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map thereof
11 reclassifying certain property thereon at the request of
12 Robert C. Sybil, Building and Land Development Division
13 File No. 238-74-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Robert C. Sybil petitioned on April 20, 1974, that the property
15 described in Section 3 below be reclassified from RS 9600 to RM 2400 and this
16 application was assigned Building and Land Development Division File No. 238-74-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-
18 ment Division was transmitted to the Zoning and Subdivision Examiner on June 19,
19 1974, and hearing was held by the Examiner on the matter June 25, 1974. The
20 report of the Examiner was filed with the Clerk of the King County Council on
21 July 10, 1974, and the Council approved the reclassification by Motion No. 1728
22 on August 26, 1974, subject to conditions which have been satisfied.

23 SECTION 3. The legal description of the property to be reclassified is
24 attached as Appendix A and is hereby made a part of this ordinance. The above
25 described property is shown on the attached map which is designated Appendix B
26 and is hereby made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning
28 Code, Resolution No. 25789, as amended, by reclassifying that property described
29 and shown in Section 3, Appendices A and B above, to RD-3600 and directs that

1 Area Map E 12-21-3 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in
3 Motion No. 1728 and said conditions are incorporated herein as though fully set
4 forth herein.

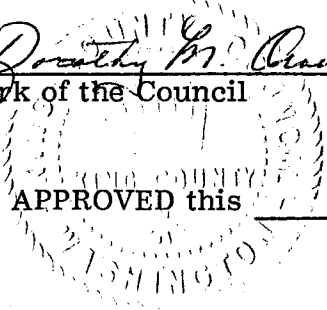

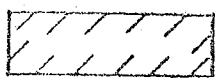
