ORDINANCE NO. 3278

AN ORDINANCE relating to the annexation of an area known as DS-1 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-1 to Des Moines Sewer District was filed with the County Council effective March 28, 1977.
2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution 1977-8, concurred with the proposed annexation.
3. Des Moines Sewer District filed a Declaration of Environmental Nonsignificance dated March 23, 1977, on the proposed annexation.
4. The County Council held a public hearing on the 13th day of June, 1977, to consider the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as DS-1 and described in Section 2 herein as approved.

SECTION 2. The area known as DS-1 to be annexed is described as follows:

Beginning at the intersection of the East-West centerline of Section 8, Township 22 North, Range 4 East, W.M., King County, Washington, and the centerline of Des Moines Way South; thence Northerly along the centerline of said Des Moines Way South to its intersection with the centerline of South 212th Street (Platted as Pine Street in the plat of Southern Pacific Land Company's 2nd Addition to Des Moines according to plat thereof, as recorded in Volume 4 of Plats, Page 49, Records of King County, Washington);

Thence Westerly along the centerline of said South 212th Street to its intersection with the Northerly extension of the centerline of the alley located between 6th Avenue S. and 5th Avenue S.

Thence Southerly along said centerline to its intersection with the centerline of South 214th Street.

Thence Southerly along said centerline to its intersection with the centerline of said East-West centerline of Section 8.

Thence Easterly along said centerline to its intersection with the centerline of Des Moines Way S. and the true point of beginning.
