1 AN ORDINANCE making an additional appro-

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. There is hereby approved and adopted an addi-
14 tional appropriation in the amount of \$150,000 to Special Programs
15 from unexpended Current Expense Fund balance.

16 SECTION 2. There is hereby approved and adopted an appro-
17 priation in the amount of \$150,000 to a new fund entitled Jail
18 Renovation and Construction Fund from Special Programs for the
19 King County Jail, Capital Improvement Program Project No. 002035.

20 SECTION 3. Ordinance No. 2988, Section 41, as amended, is
21 hereby amended to read as follows:

22 From the Current Expense Fund there is hereby appropriated
23 to:

24 Special Programs ((\$3,786,159)) \$3,936,159

26 All provisos adopted by the Council in Ordinance No. 2988
27 shall be fulfilled.
