8 ORDINANCE NO. 3312

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map thereof
11 reclassifying certain property thereon at the request of
12 L. R. McKinley, Building and Land Development Division
13 File No. 114-77-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. L. R. McKinley petitioned on January 3, 1977, that the
16 property described in Section 3 below be reclassified from RS 7200 to
17 RD 3600 and this application was assigned Building and Land Development
18 Division File No. 114-77-R.

19 SECTION 2. The report and recommendation of the Building and Land
20 Development Division was transmitted to the Zoning and Subdivision Examiner
21 on March 3, 1977, and hearing was held by the Examiner on the matter March 8,
22 1977. The report of the Examiner was filed with the Clerk of the King County
23 Council on March 30, 1977, and the Council approved the reclassification by
24 Motion No. 3031 on May 23, 1977, subject to conditions which will be satisfied
25 per the "P" suffix.

26 SECTION 3. The legal description of the property to be reclassified is
27 attached as Appendix A and is hereby made a part of this ordinance. The above
28 described property is shown on the attached map which is designated Appendix
29 B and is hereby made a part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King County Zoning
31 Code, Resolution No. 25789, as amended, by reclassifying that property described

1 and shown in Section 3, Appendices A and B above, to RD-3600-P and directs
2 that Area Map W 6-26-4 be modified to so designate.

3 SECTION 5. This reclassification is granted subject to conditions adopted in
4 Motion No. 3031 and said conditions are incorporated herein as though fully set
5 forth herein.

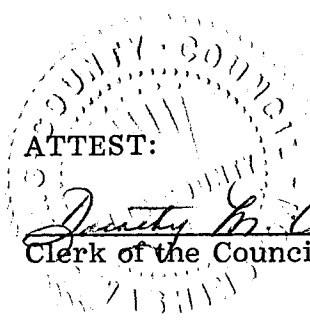
