ORDINANCE NO. 3342

AN ORDINANCE relating to the annexation of an area known as 77-8 to King County Water District No. 124.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 77-8 to King County Water District No. 124 was filed with the County Council effective June 29, 1977.
2. King County Water District No. 124 has found the petition for annexation to be sufficient and has, by Resolution 200, concurred with the proposed annexation.
3. King County Water District No. 124 filed a Declaration of Nonsignificant Impact dated May 31, 1977, on the proposed annexation.
4. The County Council held a public hearing on the 15th day of August, 1977, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 124 of the area known as 77-8 and described in Section 2 herein is approved.

SECTION 2. The area known as 77-8 to be annexed is described as follows:

Beginning at the Northwest corner of Section 14, Township 21 North, Range 4 East, W.M.;

Thence Easterly along the North line of said Section 14 to its intersection with the Northerly extension of the North-South centerline of Tracts 18, 23, 26 and 31, of West Auburn Five Acre Tracts, according to plat thereof recorded in volume 15 of plats, page 12, records of King County, Washington;

Thence Southerly along said North-South centerline and its Northerly and Southerly extensions to its intersection with the South line of the Northwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of said Section 14;

Thence Westerly along said South line and the South line of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 15, Township 21 North, Range 4 East, W.M., to its intersection with a line which is 300 feet Northeasterly of and parallel with the centerline of Knickerbocker Road (46th Place South);

Thence Northwesterly along said parallel line to its intersection with the South line of the North $\frac{1}{2}$ of the North $\frac{1}{2}$ of the said Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$;

Thence Westerly along said South line to the West line of the said Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$;

Thence Northerly along said West line to the North line of said Section 15;

Thence Easterly along said North line to the Northeast corner of said Section 15 which is also the Northwest corner of said Section 14 and the Point of Beginning.
