8 ORDINANCE NO. 3353

9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map thereof  
11 reclassifying certain property thereon at the request of  
12 Dominic Colello, Building and Land Development Division  
13 File No. 414-72-P.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Dominic Colello petitioned on April 28, 1972, that the property  
15 described in Section 3 below be reclassified from RS 7200 and RS 7200 (Potential  
16 RM 2400) to RM 900 and this application was assigned Building and Land Develop-  
17 ment Division File No. 414-72-P.

18 SECTION 2. The report and recommendation of the Building and Land  
19 Development Division was transmitted to the Zoning and Subdivision Examiner  
20 on June 20, 1972, and hearing was held by the Examiner on the matter June 27,  
21 1972. The report of the Examiner was filed with the Clerk of the King County  
22 Council on July 13, 1972, and the Council approved the reclassification by  
23 Motion No. 3047 on May 31, 1977, subject to conditions which will be satisfied  
24 per the "P" suffix.

25 SECTION 3. The legal description of the property to be reclassified is attached  
26 as Appendix A and is hereby made a part of this ordinance. The above described  
27 property is shown on the attached map which is designated Appendix B and is here-  
28 by made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning  
30 Code, Resolution No. 25789, as amended, by reclassifying that property described  
31 and shown in Section 3, Appendices A and B above, to RM 900-P and directs that

1 Area Map E 17-23-4 be modified to so designate.

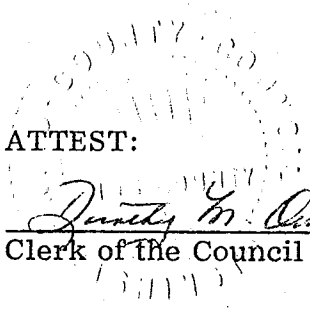
2 SECTION 5. This reclassification is granted subject to conditions adopted in

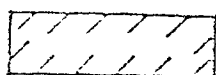

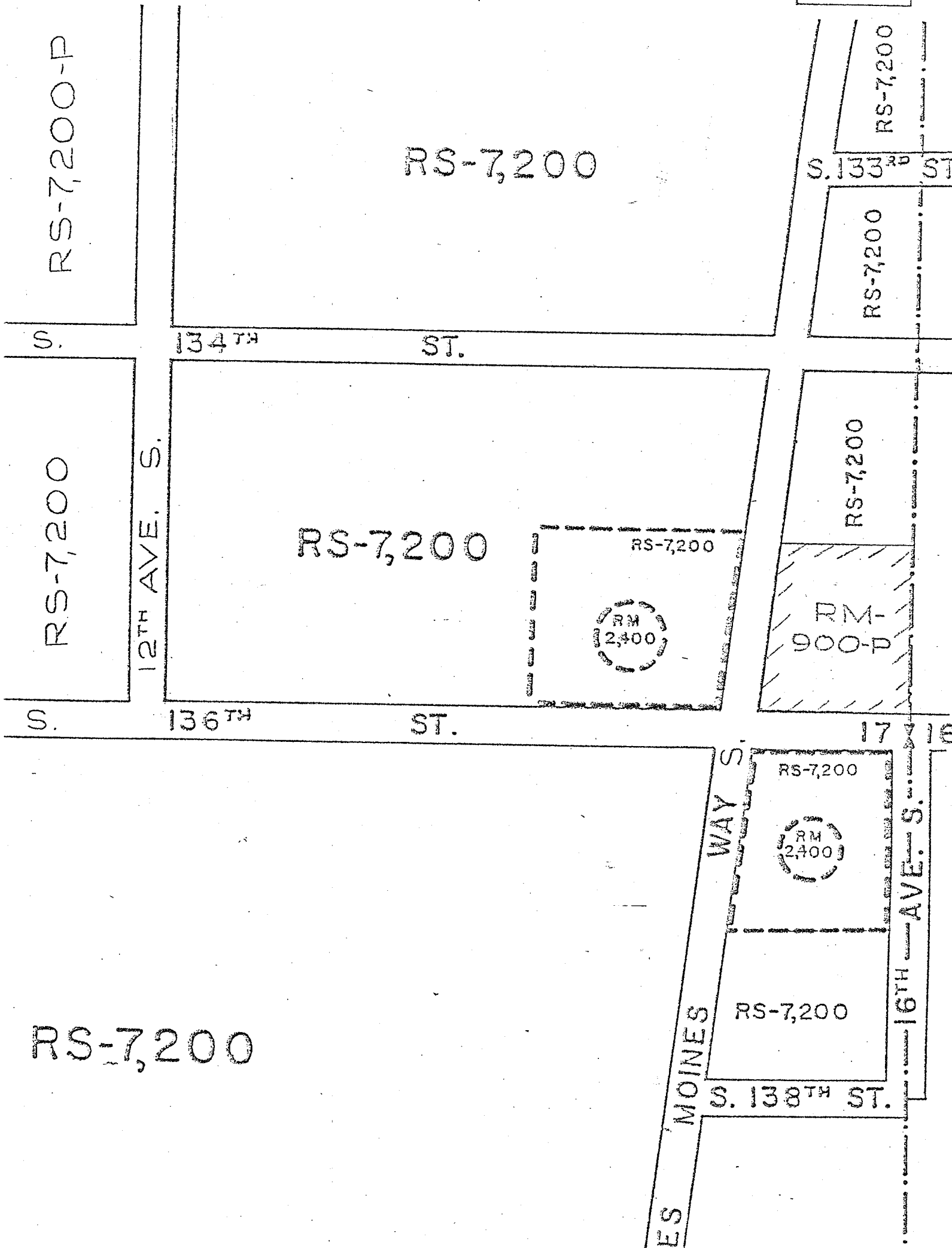
