9 ORDINANCE NO. 3358

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of Conner
13 Land Company, Building and Land Development Division File
14 No. 124-77-R.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Conner Land Company petitioned on February 16, 1977, that the
17 property described in Section 3 below be reclassified from G to RS 7200 and this
18 application was assigned Building and Land Development Division File No. 124-77-R.

19 SECTION 2. The report and recommendation of the Building and Land Develop-
20 ment Division was transmitted to the Zoning and Subdivision Examiner on
21 April 6, 1977, and hearing was held by the Examiner on the matter April 12, 1977.
22 The report of the Examiner was filed with the Clerk of the King County Council on
23 May 4, 1977, and the Council approved the reclassification by Motion No. 3020 on
24 May 16, 1977.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is
28 hereby made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying certain property
31 described and shown in Section 3, Appendices A and B above, to RS 7200 and

1 directs that Area Map W 27-26-5 be modified to so designate.

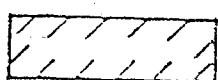
