9 AN ORDINANCE amending Ordinance No. 2851 relating  
10 to property reclassification for Weyerhaeuser Real  
Estate Company, File No. 251-75-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Ordinance No. 2851, APPENDIX A, OVERALL LEGAL DES-  
14 CRIPTION is hereby amended as follows:

15 OVERALL LEGAL DESCRIPTION:

16 All that certain real property situate in the County of King, State of  
17 Washington, being portions of Sections 17, 18, 19 & 20, T.21N., R.4E., W.M.,  
18 and being more particularly described as follows:

19 BEGINNING at a point which bears S88°44'55"E 709.41 feet and N1°05'12"E  
20 60.38 feet from the southwesterly corner of said Sec. 17; thence from said  
21 POINT OF BEGINNING S1°05'12"W 1114.80 feet; thence ~~S5°~~ S53°40'00"E 539.71  
22 feet; thence S36°20'00"W 533.26 feet; thence tangent to the preceding course  
23 along the arc of a curve to the right having a radius of 750.00 feet and a central  
24 angle of 30°00'00", an arc length of 392.70 feet; thence tangent to the preceding  
25 curve S66°20'00"W 172.18 feet; thence tangent to the preceding course along the  
26 arc of a curve to the left having a radius of 850.00 feet and a central angle of  
27 24°56'26", an arc length of 370.00 feet; thence N48°36'26"W 400.00 feet; thence  
28 N10°30'00"W 986.79 feet; thence N1°00'00"W 1090.57 feet to a point on the south-  
29 easterly line of a Bonneville Power Administration Transmission Line Easement;

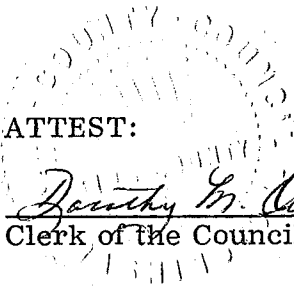
1 thence along said southeasterly line N52°58'44"E 948.67 feet; thence S38°30'00"E  
2 644.32 feet to the POINT OF BEGINNING and containing 65.40 acres of land more  
3 or less.
