

ORDINANCE NO. 3397

AN ORDINANCE making an appropriation in the amount of \$300,000 to Special Programs from the unappropriated Current Expense Fund balance to subsidize the Building Modernization Construction Fund for the purchase of an alternate site to be used for the construction of the proposed Burien Police/Court Building Capital Improvement Project No. 002016; amending the King County 1977 Capital Improvement Budget and amending Ordinance No. 2988, Section 41 and Section 70, Attachment No. 1 as amended, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation in the amount of \$300,000 to Special Programs from unappropriated Current Expense Fund Balance to subsidize the Building Modernization Construction fund for the purchase of an alternate site to be used for the construction of the proposed Burien Police/Court Building Capital Improvement Project No. 002016.

SECTION 5. The County Council finds as a fact and declares that an emergency exists and that this Ordinance is necessary for the immediate preservation of public peace, health or safety, or for the support of County government and its existing public institutions.

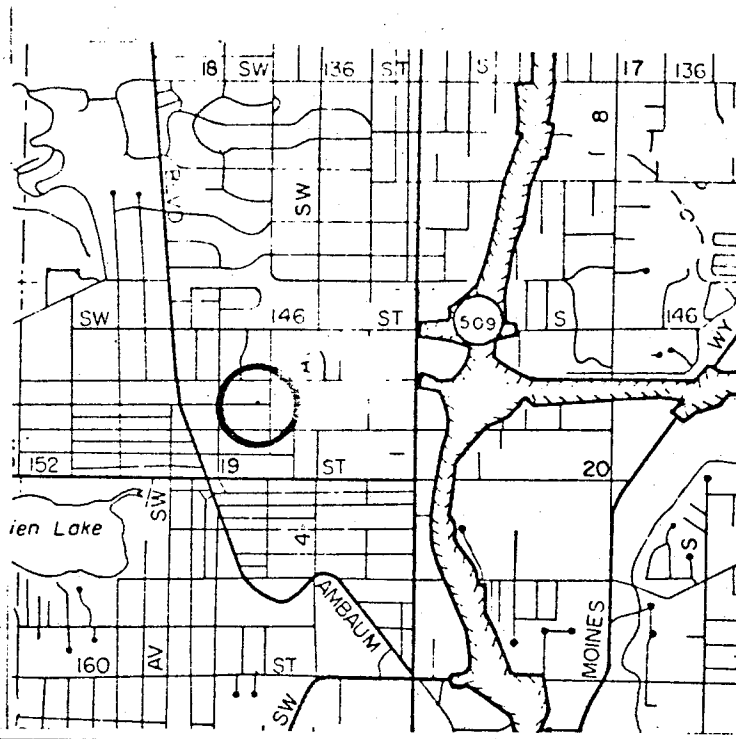
