9 ORDINANCE NO. 3437

10 AN ORDINANCE amending King County Zoning Resolution  
11 No. 25789, as amended, by amending the Zoning Map thereof  
12 reclassifying certain property thereon at the request of  
Michael R. Mastro, Building and Land Development Division  
File No. 233-77-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Michael R. Mastro petitioned on March 24, 1977, that the property  
15 described in Section 3 below be reclassified from RS 7200 to RM 900 and this  
16 application was assigned Building and Land Development Division File No. 233-77-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-  
18 ment Division was transmitted to the Zoning and Subdivision Examiner on May 17,  
19 1977, and hearing was held by the Examiner on the matter May 24, 1977. The  
20 report of the Examiner was filed with the Clerk of the King County Council on  
21 July 6, 1977, and the Council approved the reclassification by Motion No. 3119  
22 on July 11, 1977, subject to conditions which will be satisfied per the "P" suffix.

23 SECTION 3. The legal description of the property to be reclassified is attached  
24 as Appendix A and is hereby made a part of this ordinance. The above described  
25 property is shown on the attached map which is designated Appendix B and is here-  
26 by made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning  
28 Code, Resolution No. 25789, as amended, by reclassifying that property described  
29 and shown in Section 3, Appendices A and B above, to RM 1800-P and directs that

1 Area Map W 34-23-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in  
3 Motion No. 3119 and said conditions are incorporated herein as though fully set  
4 forth herein.

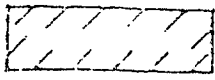
