ORDINANCE NO. 3490

AN ORDINANCE relating to the annexation of an area known as Annexation #8 to Sahalee Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Annexation #8 to Sahalee Sewer District was filed with the County Council effective October 12, 1977.

2. Sahalee Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 241, concurred with the proposed annexation.

3. Sahalee Sewer District filed a Declaration of Nonsignificant Impact dated July 15, 1977, on the proposed annexation.

4. The County Council held a public hearing on the 14th day of November, 1977, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Sahalee Sewer District of the area known as Annexation #8 and described in Section 2 herein is approved.

SECTION 2. The area known as Annexation #8 to be annexed is described as follows:

A portion of Sections 22, 27 and 28, Township 25 North, Range 6 East, W.M., in King County, Washington, described as follows:

Beginning at the northwest corner of the NE  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 22, Township 25 North, Range 6 East, W.M.;

Thence easterly along the north line thereof to the northeast corner thereof;

Thence southerly along the east line thereof to the northwest corner of the SW  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  of Section 22, Township 25 North, Range 6 East, W.M.;

Thence easterly along the north line thereof to the northeast corner thereof;

Thence southerly along the east line thereof to the southeast corner thereof;

Thence westerly along the south line thereof to the southwest corner thereof;

Thence southerly along the east line of the NW  $\frac{1}{4}$  of Section 27, Township 25 North, Range 6 East, W.M., to the southeast corner thereof;

corner thereof;

12 SE  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 28, Township 25  
North, Range 6 East, W.M., to the northeast corner  
thereof;

13 Thence N 01° 36' 37" E, 70 feet;

14 Thence N 88° 57' 00" W, 392.74 feet;

15 Thence N 01° 36' 08" E, 290 feet;

16 Thence S 88° 57' 00" E, 392.78 feet to the west line of  
17 the SW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of Section 27, Township 25 North,  
Range 6 East, W.M.;

18 Thence northerly along said west line to the northwest
