9 ORDINANCE NO. 3515

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
13 Carl Searcy, Building and Land Development Division
14 File No. 246-77-R

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Carl Searcy petitioned on May 9, 1977, that the property de-
17 scribed in Section 3 below be reclassified from SR and SR (Potential BN) to BN and
18 this application was assigned Building and Land Development Division File No.
19 246-77-R.

20 SECTION 2. The report and recommendation of the Building and Land Develop-
21 ment Division was transmitted to the Zoning and Subdivision Examiner on
22 July 19, 1977, and hearing was held by the Examiner on the matter July 26, 1977.
23 The report of the Examiner was filed with the Clerk of the King County Council on
24 August 24, 1977, and the Council approved the reclassification by Motion No. 3215
25 on September 26, 1977, subject to conditions which will be satisfied per the "P"
26 suffix.

27 SECTION 3. The legal description of the property to be reclassified is attached
28 as Appendix A and is hereby made a part of this ordinance. The above described
29 property is shown on the attached map which is designated Appendix B and is
30 hereby made a part of this ordinance.

31 SECTION 4. The King County Council does hereby amend King County Zoning
Code, Resolution No. 25789, as amended, by reclassifying certain property de-
scribed and shown in Section 3, Appendices A and B above, to BN-P and

1 directs that Area Map E 25-22-5 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in
3 Motion No. 3215 and said conditions are incorporated herein as though fully set
4 forth herein.

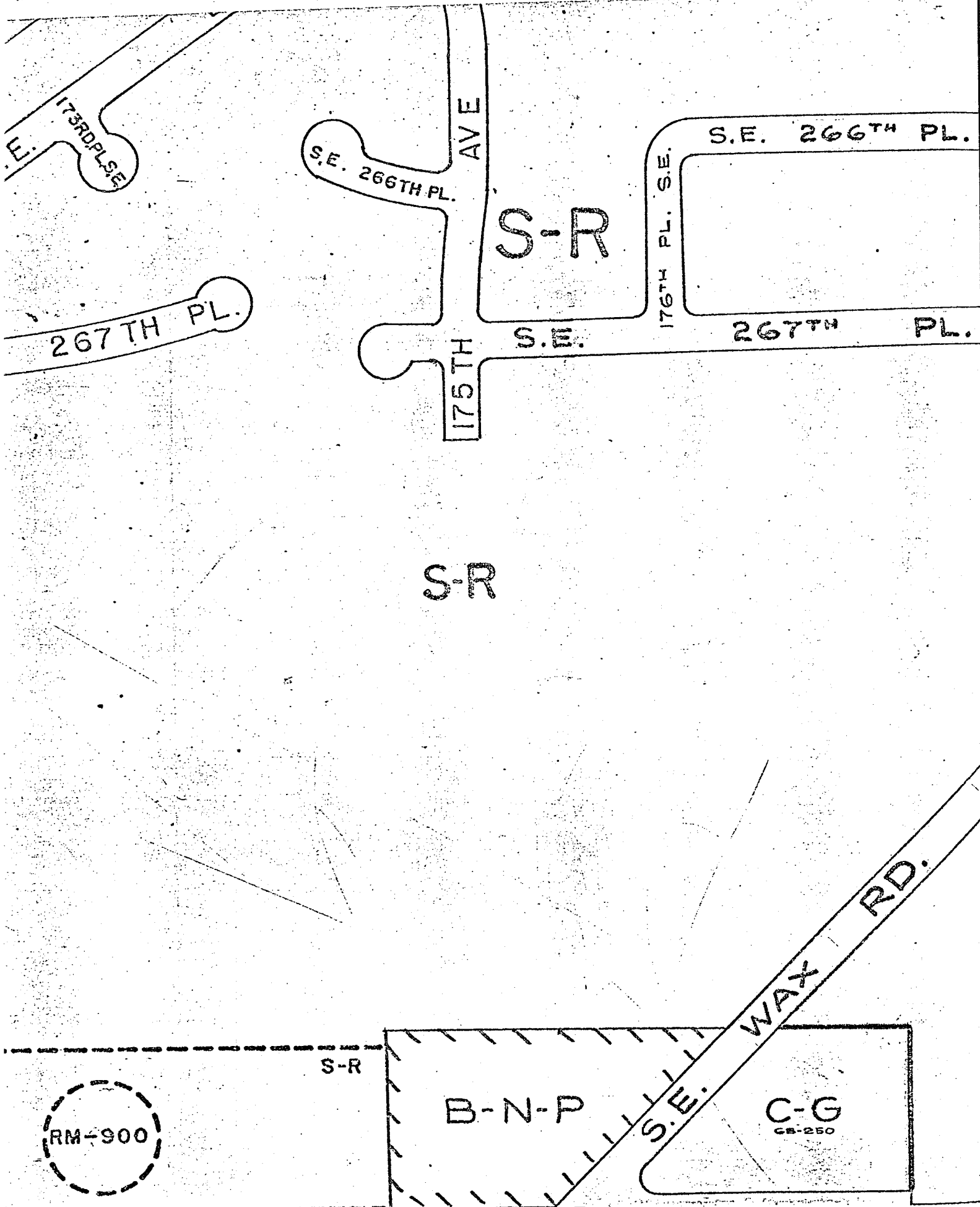
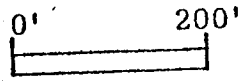
