4 ORDINANCE NO. 3528

5 AN ORDINANCE approving the sewer general  
6 comprehensive plan for Des Moines Sewer  
7 District.

8 STATEMENT OF FACT:

- 9 1. Des Moines Sewer District submitted a sewer general  
10 comprehensive plan to King County for approval as required  
11 by RCW 56.08.020 and Chapter 13.24 KCC.  
12 2. Des Moines Sewer District filed a Declaration of Environ-  
13 mental Non-Significance dated July 8, 1977, on the proposed  
14 plan.  
15 3. In December, 1976, the Utilities Technical Review  
16 Committee reviewed the proposed plan and by U.T.R.C. No. 76-2  
17 dated December 15, 1976, recommended approval.

18 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

19 SECTION 1. The Des Moines Sewer District general comprehen-  
20 sive plan entitled "Wastewater Facilities Plan" March, 1976,  
21 attached as Exhibit A, is hereby approved.

22 SECTION 2. No right-of-way construction permits for construc-  
23 tion of sewer facilities shall be issued to Des Moines Sewer  
24 District or within Des Moines Sewer District unless the Division  
25 of Real Property receives certification from the Division of  
26 Building and Land Development that such construction is consistent  
27 with the comprehensive plan approved herein and this ordinance.

28 SECTION 3. Where conflicts exist between the Des Moines  
29 Sewer District planning area and the planning areas of adjacent  
30 districts or municipalities, such conflicts shall be resolved by  
31 the districts and/or municipalities proposing to provide service.

32 SECTION 4. This approval shall remain in effect for a  
33 period of five years from the effective date of this ordinance,  
except that any sewer facilities constructed or under contract  
for construction prior to the expiration of this approval shall

1 not require further approval. Prior to the expiration of this  
2 approval, the District must submit a revised and updated plan for  
3 those facilities not then under contract.


