AN ORDINANCE relating to the annexation of an area known as P-251A to Cascade Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as P-251A to Cascade Sewer District was filed with the County Council effective November 28, 1977.
- 2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolutions 709 and 710, concurred with the proposed annexation.
- 3. Cascade Sewer District filed a Declaration of Nonsignificant Impact dated July 7, 1977, on the proposed annexation.
- 4. The County Council held a public hearing on the 3rd day of famuly, 1978, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

 $\underline{\text{SECTION 1}}$. The annexation by Cascade Sewer District of the area known as P-251A and described in Section 2 herein is approved.

 $\underline{\text{SECTION 2}}$. The area known as P-251A to be annexed is described as follows:

Beginning at the intersection of the East line of Section 16, Township 22 North, Range 5 East, W.M. with the South line of the North half of the North half of Section 15, Township 22 North, Range 5 East, W.M. said point being on the existing boundary of Cascade Sewer District.

Thence Southerly along said East line to the North line of the South 210 feet of the Southeast quarter of the Northeast quarter of said Section 16;

Thence Westerly along said North line to the West line of said Southeast quarter of the Northeast quarter of said Section 16;

Thence Northerly along said West line and along the West line of the Northeast quarter of the Northeast quarter to the North line of said Section 16;

Thence Easterly along said North line and along the North line of Section 15, Township 22 North, Range 5 East, W.M. to the East line of the West half of the West half of said Section 15;

Thence Southerly along said East line to the South line of the North half of the North half of said Section 15;
