9 ORDINANCE NO. 3571

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
Thomas J. Daves, Building and Land Development Division
File No. 256-77-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Thomas J. Daves petitioned on June 15, 1977, that the property
15 described in Section 3 below be reclassified from RS 7200 to RD 3600 and this
16 application was assigned Building and Land Development Division File No. 256-77-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-
18 ment Division was transmitted to the Zoning and Subdivision Examiner on
19 September 20, 1977, and hearing was held by the Examiner on the matter September 27,
20 1977. The report of the Examiner was filed with the Clerk of the King County Council
21 on October 19, 1977, and the Council approved the reclassification by Motion
22 No. 3285 on November 7, 1977.

23 SECTION 3. The legal description of the property to be reclassified is attached
24 as Appendix A and is hereby made a part of this ordinance. The above described
25 property is shown on the attached map which is designated Appendix B and is here-
26 by made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning
28 Code, Resolution No. 25789, as amended, by reclassifying that property described
29 and shown in Section 3, Appendices A and B above, to RD 3600 and directs that Area

1 Map W 4-23-4 be modified to so designate.
