ORDINANCE NO. 3580

AN ORDINANCE relating to the withdrawal of an area known as Meredith from Lakehaven Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the withdrawal of an area known as Meredith from Lakehaven Sewer District was filed with the County Council effective December 13, 1977.
2. Lakehaven Sewer District has found the petition for withdrawal to be sufficient and has, by Resolution 77-546, concurred with the proposed withdrawal.
3. Lakehaven Sewer District filed a Declaration of Nonsignificant Impact dated November 1, 1977, on the proposed withdrawal.
4. The County Council held a public hearing on the 30th day of January, 19 78, and has considered the criteria set forth in RCW 56.02.060.

SECTION 1. The withdrawal by Lakehaven Sewer District of the area known as Meredith and described in Section 2 herein is approved.

SECTION 2. The area known as Meredith to be withdrawn is described as follows:

That portion of Section 2, Township 21 North, Range 4 East W.M., in King County, Washington, described as follows:

Beginning at the intersection of the centerline of 65th Avenue South (Meredith Road) and the East line of said Section 2;

Thence South along said East line to the North line of the East half of the East half of the Southeast quarter of said Section 2;

Thence West along the said North line to the West line of the East half of the East half of said Southeast quarter of said Section 2;

Thence South along said West line to the South line of the North half of the North half of the West half of the Southeast quarter of the Southeast quarter of said Section 2;

Thence West along said South line to the East line of the Southwest quarter of the Southeast quarter of said Section 2;

Thence South along said East line to the South line of said Section 2;
