9 ORDINANCE NO. 3590

10 AN ORDINANCE amending King County Zoning Resolution  
11 No. 25789, as amended, by amending the Zoning Map thereof  
12 reclassifying certain property thereon at the request of  
13 King County, Building and Land Development Division File  
14 No. 155-77-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. King County petitioned on June 29, 1977, that the property de-  
16 scribed in Section 3 below be reclassified from RS 15000 (Potential RM 2400) to  
17 RS-15000 and this application was assigned Building and Land Development  
18 Division File No. 155-77-R.

19 SECTION 2. The report and recommendation of the Building and Land Develop-  
20 ment Division was transmitted to the Zoning and Subdivision Examiner on  
21 September 6, 1977, and hearing was held by the Examiner on the matter  
22 September 13, 1977. The report of the Examiner was filed with the Clerk of the  
23 King County Council on October 13, 1977, and the Council approved the reclassifi-  
24 cation by Motion No. 3296 on November 14, 1977.

25 SECTION 3. The legal description of the property to be reclassified is  
26 attached as Appendix A and is hereby made a part of this ordinance. The above  
27 described property is shown on the attached map which is designated Appendix  
28 B and is hereby made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning  
30 Code, Resolution No. 25789, as amended, by reclassifying that property described  
31 and shown in Section 3, Appendices A and B above, to RS 15000 and

1 directs that Area Map E 6-23-3 be modified to so designate.



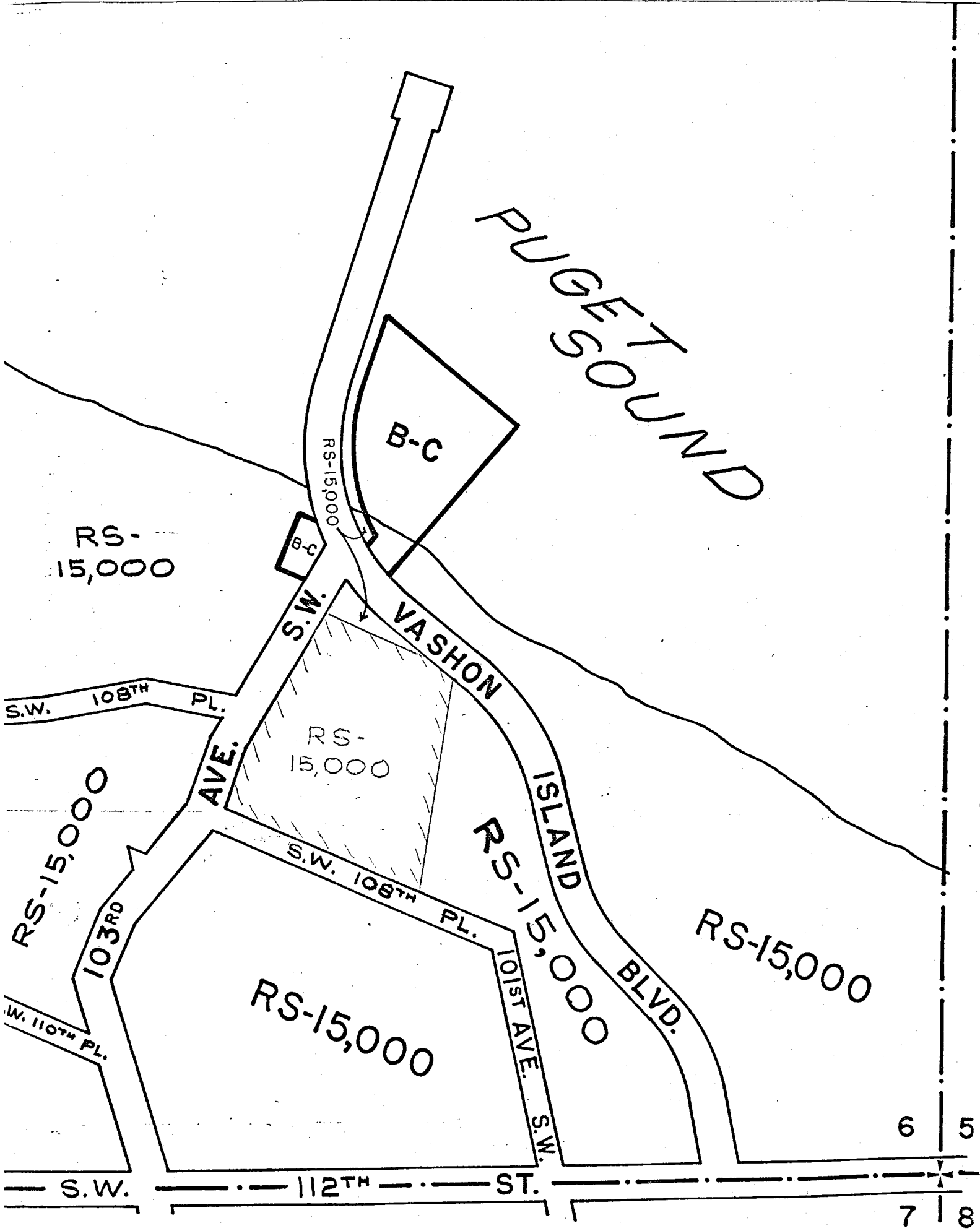
