9 ORDINANCE NO. 3591

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of Pierre
13 Lieurance Interiors, Inc., Building and Land Development
14 Division File No. 162-77-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Pierre Lieurance Interiors, Inc., petitioned on July 21, 1977,
16 that the property described in Section 3 below be reclassified from RS 7200
17 (Potential RM 1800) to RM 1800 and C-G-P and this application was assigned
18 Building and Land Development Division File No. 162-77-R.

19 SECTION 2. The report and recommendation of the Building and Land Develop-
20 ment Division was transmitted to the Zoning and Subdivision Examiner
21 October 4, 1977, and hearing was held by the Examiner on the matter October 11, 1977
22 The report of the Examiner was filed with the Clerk of the King County Council on
23 November 9, 1977, and the Council approved the reclassification by Motion No. 3298
24 on November 14, 1977, subject to conditions which will be satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is hereby
28 made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying that property described
31 and shown in Section 3, Appendices A and B above, to RM-1800-P and C-GP and

1 directs that Area Map W 6-26-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in
3 Motion No. 3298 and said conditions are incorporated herein as though fully
4 set forth herein.

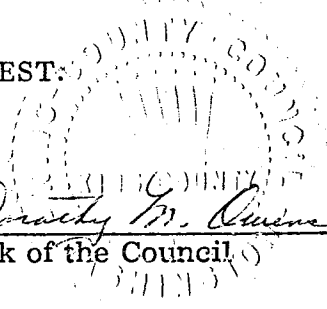
