8 ORDINANCE NO. 3641

9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map thereof  
11 reclassifying certain property thereon at the request of  
Robert L. Perry, Building and Land Development Division  
File No. 252-77-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Robert L. Perry petitioned on June 1, 1977, that the property  
14 described in Section 3 below be reclassified from BN to RM-900 and this appli-  
15 cation was assigned Building and Land Development Division File No. 252-77-R.

16 SECTION 2. The report and recommendation of the Building and Land Develop-  
17 ment Division was transmitted to the Zoning and Subdivision Examiner on August 16,  
18 1977, and hearing was held by the Examiner on the matter August 23, 1977. The  
19 report of the Examiner was filed with the Clerk of the King County Council on  
20 October 27, 1977, and the Council approved the reclassification by Motion  
21 No. 03339 on December 19, 1977, subject to conditions which will be satisfied  
22 per the "P" suffix.

23 SECTION 3. The legal description of the property to be reclassified is attached  
24 as Appendix A and is hereby made a part of this ordinance. The above described  
25 property is shown on the attached map which is designated Appendix B and is here-  
26 by made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning  
28 Code, Resolution No. 25789, as amended, by reclassifying that property described  
29 and shown in Section 3, Appendices A and B above, to RM-900-P and directs that

1 Area Map W 9-23-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in  
3 Motion No. 03339 and said conditions are incorporated herein as though fully set  
4 forth herein.
