ORDINANCE NO. 3819

AN ORDINANCE approving and adopting collective bargaining agreements/salary addenda negotiated by and between King County and certain labor organizations; establishing the effective date of said agreements; and repealing Ordinance No. 2867 and Ordinance No. 3272.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 2867 and Ordinance No. 3272 are each hereby repealed.

SECTION 2. Approval and adoption is hereby made of the collective bargaining agreements/salary addenda attached hereto and by this reference made a part hereof negotiated by and between King County and the following labor organizations:
