6 ORDINANCE NO. 3842

7 AN ORDINANCE amending King County Zoning Resolution
8 No. 25789, as amended, by amending the Zoning Map
9 thereof reclassifying certain property thereon at the
request of Rembold Corporation, Building and Land
Development Division File No. 122-77-R.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Rembold Corporation petitioned on February 16,
12 1977, that the property described in Section 3 below be reclassified
13 from RS 7200 (Potential RD 3600) to RD 3600 and this application was
14 assigned Building and Land Development Division File No. 122-77-R.

15 SECTION 2. The report and recommendation of the Building and
16 Land Development Division was transmitted to the Zoning and Subdivi-
17 sion Examiner on April 5, 1977, and hearing was held by the Examiner
18 on the matter April 12, 1977. The report of the Examiner was filed
19 with the Clerk of the King County Council on May 4, 1977, and the
20 Council approved the reclassification by Motion No. 03010 on May 9,
21 1977.

22 SECTION 3. The legal description of the property to be re-
23 classified is attached as Appendix A and is hereby made a part of
24 this ordinance. The above described property is shown on the
25 attached map which is designated Appendix B and is hereby made a
26 part of this ordinance.

27 SECTION 4. The King County Council ~~does~~ hereby amend King
28 County Zoning Code, Resolution No. 25789, as amended, by reclassi-

1 fying that property described and shown in Section 3, Appendices A
2 and B above, to RD 3600 and directs that Area Map E 7-26-4 be modi-
3 fied to so designate.

4 SECTION 5. This reclassification is granted subject to con-
5 ditions adopted in Motion No. 03010 and said conditions are incor-
6 porated herein as though fully set forth herein.
