ORDINANCE NO. 3874

1 AN ORDINANCE making an appropriation of
2 \$21,400 from the Housing and Community
3 Development Block Grant to the Affirmative
4 Action Section of the County Administrator's
5 Office in the Current Expense Fund for the
6 purpose of funding the Contract Compliance
7 Officer position and supportive activities;
8 amending Ordinance No. 3492, Section 9 as
9 amended.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. An appropriation of \$21,400 from the Housing
12 and Community Development Block Grant to the Affirmative Action
13 Section of the County Administrator's Office in the Current
14 Expense Fund for the purpose of funding the Contract Compliance
15 Officer position and supportive activities is hereby approved
16 and adopted.

17 SECTION 2. Ordinance No. 3492, Section 9, is hereby
18 amended to read as follows:

19 From the Current Expense Fund there is hereby appropriated
20 to:

21 County Administrator's Office ((\$576,122)) \$597,522

22 Provided that:

23 1) By February, 1979 the Executive shall, based on a
24 comprehensive review, recommend amendments to Ordinance No. 198
25 (regarding contract compliance).

26 2) The Executive shall include in the Affirmative Action
27 Quarterly Report a minority employment profile displaying contract
28 compliance information for all service and construction contracts
29 including:

30 a. A minority and non-minority workforce profile for
31 each contract monitored, classified by service or construc-
32 tion and a total profile for each of the two classes.

33 b. The workforce profile for each service and construc-
tion contract shall state the subcontractors, the firm, and
the value of each subcontract, distinguishing those which
are minority and non-minority.

c. A discussion of action taken by the County in those cases where the report, or previous reports, have noted non-compliance with Ordinance No. 198 by an individual contractor.

3) Should the County continue to contract with non-County agencies to perform the contract compliance function; no reimbursement shall be made to such agencies where submitted reports fail to provide a monthly minority employee utilization report or adequate explanation for the lack thereof for all contracts under the agencies' jurisdiction, not to include annual service or vendor contracts.
