7                    AN ORDINANCE amending King County Zoning Resolu-  
8                    tion No. 25789, as amended, by amending the Zoning  
9                    Map thereof reclassifying certain property thereon  
                  at the request of Jessie C. Parker, Building and  
                  Land Development Division File No. 215-78-R.

10                   BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11                   SECTION 1. Jessie C. Parker petitioned on November 21, 1977,  
12 that the property described in Section 3 below be reclassified from  
13 RS 7200 (Potential RM 2400) to RM 2400 and this application was  
14 assigned Building and Land Development Division File No. 215-78-R.

15                   SECTION 2. The report and recommendation of the Building and  
16 Land Development Division was transmitted to the Zoning and Subdivi-  
17 sion Examiner on February 16, 1978, and hearing was held by the  
18 Examiner on the matter February 23, 1978. The report of the Exami-  
19 ner was filed with the Clerk of the King County Council on April 3,  
20 1978, and the Council approved the reclassification by Motion No.  
21 03495 on May 8, 1978, subject to conditions.

22                   SECTION 3. The legal description of the property to be re-  
23 classified is attached as Appendix A and is hereby made a part of  
24 this ordinance. The above described property is shown on the at-  
25 tached map which is designated Appendix B and is hereby made a part  
26 of this ordinance.

27                   SECTION 4. The King County Council ~~does~~ hereby amend King  
28 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
29 fying that property described and shown in Section 3, Appendices A

1 and B above, to RM 2400 and directs that Area Map W 19-23-4 be  
2 modified to so designate.
