7 ORDINANCE NO.: 3900

8 AN ORDINANCE amending King County Zoning Resolu-
9 tion No. 25789, as amended, by amending the Zoning
10 Map thereof reclassifying certain property thereon
at the request of Mrs. Violet M. Larson, Building
and Land Development Division File No. 142-77-R.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. Mrs. Violet M. Larson petitioned on May 5, 1977,
13 that the property described in Section 3 below be reclassified from
14 SR to BC and this application was assigned Building and Land Devel-
15 opment Division File No. 142-77-R.

16 SECTION 2. The report and recommendation of the Building and
17 Land Development Division was transmitted to the Zoning and Subdi-
18 vision Examiner on July 7, 1977, and hearing was held by the Examin-
19 er on the matter July 12, 1977. The report of the Examiner was
20 filed with the Clerk of the King County Council on August 3, 1977,
21 and the Council approved the reclassification by Motion No. 03150
22 on August 8, 1977.

23 SECTION 3. The legal description of the property to be re-
24 classified is attached as Appendix A and is hereby made a part of
25 this ordinance. The above described property is shown on the
26 attached map which is designated Appendix B and is hereby made a
27 part of this ordinance.

1 SECTION 4. The King County Council does hereby amend King
2 County Zoning Code, Resolution No. 25789, as amended, by reclassifi-
3 ing that property described and shown in Section 3, Appendices A
4 and B above, to BC and direct that Area Map E 15-24-7 be modified
5 to so designate.



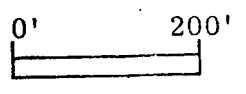
OVERALL LEGAL DESCRIPTION:
