6 ORDINANCE NO. 3953

7 AN ORDINANCE amending King County Zoning Resolution
8 No. 25789, as amended, by amending the Zoning Map
9 thereof reclassifying certain property thereon at
10 the request of Ross Olds, Building and Land Develop-
11 ment Division File No. 264-75-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Ross Olds petitioned on September 26, 1975, that
14 the property described in Section 3 below be reclassified from SR
15 to RD 3600 and this application was assigned Building and Land
16 Development Division File No. 264-75-R.

17 SECTION 2. The report and recommendation of the Building and
18 Land Development Division was transmitted to the Zoning and Sub-
19 division Examiner on November 18, 1975, and hearing was held by the
20 Examiner on the matter November 25, 1975. The report of the Exam-
21 iner was filed with the Clerk of the King County Council on May 5,
22 1976, and the Council approved the reclassification by Motion No.
23 2461 on May 10, 1976, subject to conditions which will be satisfied
24 per the "P" suffix.

25 SECTION 3. The legal description of the property to be re-
26 classified is attached as Appendix A and is hereby made a part of
27 this ordinance. The above described property is shown on the at-
28 tached map which is designated Appendix B and is hereby made a part
29 of this ordinance.

30 SECTION 4. The King County Council does hereby amend King
31 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
fying that property described and shown in Section 3, Appendices A

1 and B above, to RD 3600-P and directs that Area Map W 15-21-4 be
2 modified to so designate.

3 SECTION 5. This reclassification is granted subject to condi-
4 tions adopted in Motion No. 2461 and said conditions are incorpora-
5 ted herein as though fully set forth herein.

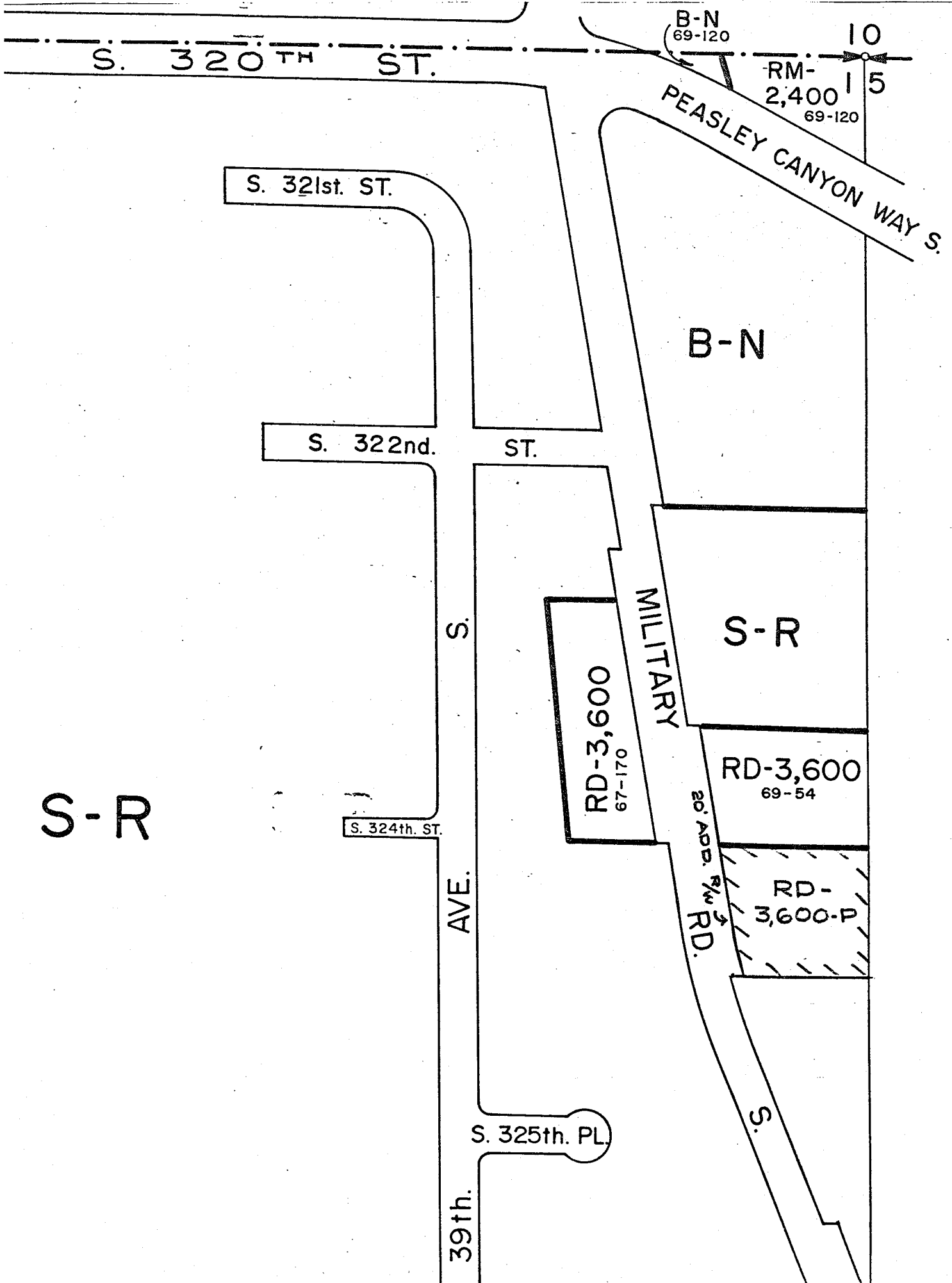
